What you need:

- A clean potty
- A separate sink for cleaning the potty. The potty should be cleaned in the changing unit sink which is to be cleaned and disinfected after use (as per section 5.5 Infection Prevention and Control)
- A sink for washing yours and the child's hands. Children will be encouraged to use the sinks in the main toilet area as opposed to the one in the changing unit

Guidance and Procedures:

- Infection Prevention and Control in Childcare Settings states that when handling body fluids such as urine and bowel movements, staff should ensure they only handle them when wearing personal protective equipment such as disposable gloves and an apron, (see staff PPE below).
- Children are required to follow good hygiene practice after using the potty by washing their hands with soap and warm water and drying with a paper towel. This should then be disposed of in a lined bin.
- To minimise the risk of germs being present and spread, the area in which the potty is kept should be kept clean, safe, dry and ready for use.
- The potty should be stored away from other children. In Blackwood ELC it will be stored in the locked changing unit.

Cleaning & disinfecting the potty:

- After the child has used the potty, staff should put on PPE and pour contents of the potty into a toilet.
- Remove residue with toilet roll and flush down the toilet.
- Clean the potty with detergent and water or paper towels with general-purpose detergent and hand-hot water.
- Use the pink disinfectant spray after cleaning with detergent.
- Dry with paper towels or kitchen roll.
- Remove PPE, wash your hands, then if required help the child to wash their hands.
- Put potty in a clean, dry area do not store potties one inside the other.

Staff PPE:

- Staff are required to wear disposable gloves and a disposable apron when changing children or handling urine and/or bowel movements.
- Staff should wash their hands before putting on PPE then after taking it off.

PPE should be placed in a nappy sack, double bagged and put into the nappy bin,
